- High sub-sectorial and geographical concentration
  - □ 70% of all firms are concentrated in just 5 manufacturing subsectors
    - ☐ food products & beverages
    - non-metallic mineral products
    - ☐ fabricated metal products
    - ■electrical machinery and chemicals.



- High sub-sectorial and geographical concentration
  - More than 55% of registered manufacturing enterprises are located in Beirut and Mount Lebanon regions
  - Scattered over residential and agricultural areas, in addition to areas earmarked for commercial and industrial activity.



- Small scale of industry.
  - ☐ 75% employ less than 20 workers and generate20% of gross MVA
  - □ 3% employ more than 100 workers and generate50% of the gross MVA
- High cost of production due to:
  - Unreliability of infrastructural services
  - Scarcity of land




- Inadequate land zoning
- Strong global competition
- A small domestic market
- Weak private sector investment
- Weak environmental sustainability

# Challenges

- Absence of a national plan to create organize and develop IZ.
- High cost of land.
- High cost of labor.
- High cost of energy.
- Scarcity of land leasing operations.
- Lack of services.
- Lack of appropriate infrastructure.



# Challenges


- No accurate estimates of how many industrial and commercial enterprises occupy the IZ.
- Difficult for the government to monitor and implement environmental protection measures.
- □ IZ do not offer dedicated support infrastructure or services or any fiscal incentives to enterprises that occupy them.



# Challenges

 Scattering of industry prevents clustering and the deepening of value chains and diminishes the potential benefits resulting from the

economies of scale.



#### New IZs

- New Industrial Zones
- Four IZs have been planned in a UNIDO MOI project
- ☐ Three of them are part of a national government priority (governmental decision #75 April 2018)
  - □ Tourbol Koussaya, Bekaa
  - Baalbek, Baalbak El Hermel
  - Al Qaa, Baalbak El Hermel
- □ The New IZ are part of the Capital Investment Plan (CEDRE)



# First Phase of the Strategy



- Setting up three IZsAl-Qaa, Baalbak andTourbol
- Creation of 46,000job opportunity of which 8,000 are direct opportunities
- Infrastructureapproximate cost150,000,000 \$

## Tourbol, Baalbek & Al Qaa IZs

- These IZs attracted financial commitments for their construction and development of:
  - □ 7 million Euro from the Government of Italy
  - 52 million Euro from the EIB
- In addition, the European Bank for Reconstruction and Development (EBRD) is considering a loan of USD 46 million for investment in the development of these zones.





#### Baalbek IZ

- ☐ Approximate area of 500,000 m²
- 85 plots of area between 750 & 10,000 m²
- 4,000 job opportunity of which1,000 are direct opportunities
- ☐ 50% of the land is being exploited
- □ Annual rental fees 6\$, including services between 32 and 47\$
- Approximate infrastructure cost: 25,000,000 \$








# Tourbol-Kousaya IZ

- ☐ Approximate area of 1,850,000 m²
- 174 plots of area between 750 & 10,000 m²
- 24,000 job opportunity of which3,000 are direct opportunities
- 28% of the land is being exploited
- □ Annual rental fees 12 \$, including services between 23 and 58 \$
- □ Approximate infrastructure cost: 70,000,000 \$






### Al Qaa IZ

- ☐ Approximate area of 1,800,000 m²
- ☐ 365 plots of area between 1,000 & 9,000 m<sup>2</sup>
- □ 18,500 job opportunity of which 3,700 are direct opportunities
- ☐ 65% of the land is being exploited
- □ Annual rental fees 12 \$, including services between 8 and 39 \$
- □ Approximate infrastructure cost: 54,000,000 \$
